




HIV Transmission Routes in Ukraine






Sexual HIV Transmission among People with Newly Diagnosed HIV in Ukraine in 2019, by Administrative Territorial Units





Volume of HIV testing and number of detected HIV infection cases in Ukraine in 2017-2019



Order of the MoH of Ukraine of 15.12.2003 N 582 "On approval of clinical protocols for obstetric and gynecological care"

- Two tests for HIV during pregnancy
- Zidovudine started at 28 weeks of pregnancy
- Discontinuation after delivery



Order of the MoH of Ukraine Nº716 of 14.11.2007 "On approval of clinical protocol for obstetric and gynecological care — Prevention of mother-to-child transmission of HIV"

- Two HIV tests during pregnancy
- Prescription of 3 antiretroviral drugs starting at 24 weeks of pregnancy
- Discontinuation after delivery




Order Nº449 of 16.05.2016. Unified clinical protocol for primary, secondary (specialized) and tertiary (highly specialized) medical care "Prevention of mother-to-child transmission of HIV"

- Three HIV tests for pregnant women (if the patient belongs to vulnerable populations or in case of sero-discordant couples)
- Initiation of ART immediately after establishment of HIV (+) status
- Option "B+" has been determined as the key PMTCT strategy in the country
- Continuation of ART after delivery








Number of HIV-positive pregnant women and children born to them in Ukraine, 2015-2019





Children born to HIV positive women, whose HIV diagnosis was confirmed, in Ukraine in 2017-2019




Registered children born to HIV positive mothers whose HIV diagnosis was confirmed in the reporting year

Registered number of people with HIV diagnosis by the end of reporting year




Children born to HIV positive women, whose HIV diagnosis is yet to be confirmed, in Ukraine in 2017-2019



People registered in the reporting year with the newly established HIV diagnosis


People with HIV diagnosis registered by the end of reporting year

Health services in Ukraine starting from April 1, 2020

Resolution of the Cabinet of Ministers of Ukraine of 05.02.2020 №65 "Some issues of implementation of the program of state guarantees of health care in 2020". Starting from April 1, 2020 by the National Health Service of Ukraine started financing of health care facilities of emergency, secondary (specialized), tertiary (highly specialized), palliative medical care, medical rehabilitation, health care to children under 16, health care related to pregnancy and childbirth.



Standards of examination of women during pregnancy

A health care facility that has signed a contract with the NHS for the provision of an outpatient service package should ensure that all necessary examinations are carried out in accordance with the industry standards, including the examination of women for HIV infection.

Ukrainan legislation of testing pregnant women for HIV

In accordance with the requirements of Art. 15 of the Law of Ukraine "Basic Principles of Legislation of Ukraine on Health Care"... the implementation of state policy of health care in administrative territorial units of Ukraine is carried out by... the local public administrations ", which should ensure access of all pregnant women to free HIV testing, which is guaranteed by Article 6 of the Law of Ukraine "On Counteracting the Spread of Diseases Caused by Human Immunodeficiency Virus (HIV) and on Legal and Social Protection of People Living with HIV"



Status of implementation of the programme to prevent motherto-child transmission in 2019

- The total number of HIV-positive pregnant women is 2203
- The total number of births is 2083
- The prevalence of HIV among pregnant women is 0.72
- Coverage of pregnant women with HIV testing 99.3%



■ Coverage of HIV positive women with ARV treatment - 95,6%

Over 93.4% of HIV positive women continue ART after delivery

■ The number of women whose HIV positive status was established before pregnancy is growing — from 54.2% in 2017 to 65.2% in 2019



- Cesarean section as a method of delivery was performed in 27.2% of HIV-positive mothers (in 2018 - 31.0%)
- In 2019, among 766 women who learned about their HIV-positive status during pregnancy and childbirth, the diagnosis of HIV infection was established mainly in the second trimester of pregnancy 44.9%.
- In the third trimester and after childbirth, the diagnosis was generally established in 26.4% of cases, i.e., almost every 4th woman did not receive a comprehensive PMTCT health services in time, which significantly increased the risk of HIV infection of their child.



- In 2019, incidence of MTCT in Ukraine, according to early diagnosis of HIV infection, accounted for 1.6% - 31 cases of mother-to-child transmission of HIV.
- Incidence of MTCT was calculated based on the results of a cohort analysis in the process of establishing the final HIV infection diagnosis among children born to HIV-positive women in 2017 - 3.3%
